Licensing Manager

Reporting to the Head of Licensing & Education, the Education Manager will be responsible for overseeing day-to-day education operations, resolving complex education matters, guiding policy and program implementation, and contributing to operational improvements.

We seek a manager with experience in government or regulatory settings, who possesses an understanding of procedural fairness and compliance, and has the ability to translate legislation into actionable policy. This individual has worked closely with regulations and legislation and can apply them to operational functions.

The team

The AIC Licensing team is responsible for overseeing and managing the process of reviewing applications, providing guidance, granting, renewing, and revoking licenses for individuals or organizations within the insurance industry. The team plays a critical role in protecting consumers by ensuring that only qualified and compliant entities and individuals are authorized to offer insurance services in Alberta.

The role

AIC is looking for a manager who fosters a culture of collaboration, service excellence, and continuous improvement while serving as a liaison between the Licensing team and other internal and external stakeholders. They are passionate about regulatory compliance, upholding licensing standards, fostering effective stakeholder relationships and contributing to AIC's operational excellence.

- Supervise and coordinate the daily work of the Licensing team to ensure timely, accurate processing of all licensing applications, renewals, transfers, and terminations.
- Provide training, mentorship, and technical guidance to new and existing team members.
- Maintain data accuracy and reporting integrity in licensing systems; contribute to regular operational reporting and analysis.
- Identify and address performance issues, risks, or compliance concerns; escalating to the Head of Licensing & Education as appropriate.
- Represent AIC's interests and gather input at external consultations, forums, and policy discussions.
- Address stakeholder concerns or escalations promptly and professionally with a solution-oriented mindset.
- Lead the development, review and implementation of licensing policies, processes, and procedures.
- Prepare and review reports on license suspensions and revocations.

Qualifications & experience

- At least seven years' progressive experience in a regulatory, licensing or public service environment, with two or more of those in a supervisory position.
- Demonstrated supervisory experience overseeing an operational area.
- Batchelor's degree in business, public administration, legal studies, or a related field
- Certification in project management (e.g., PMP, CAPM) or change management (e.g., PROSCI) is an asset.
- Courses or training in quality assurance or regulatory policy are an asset.
- Possession of a Management or Supervisory Certificate OR completion of coursework in management, supervision, or a closely related field is an asset.
- Combination of education and experience will be considered
