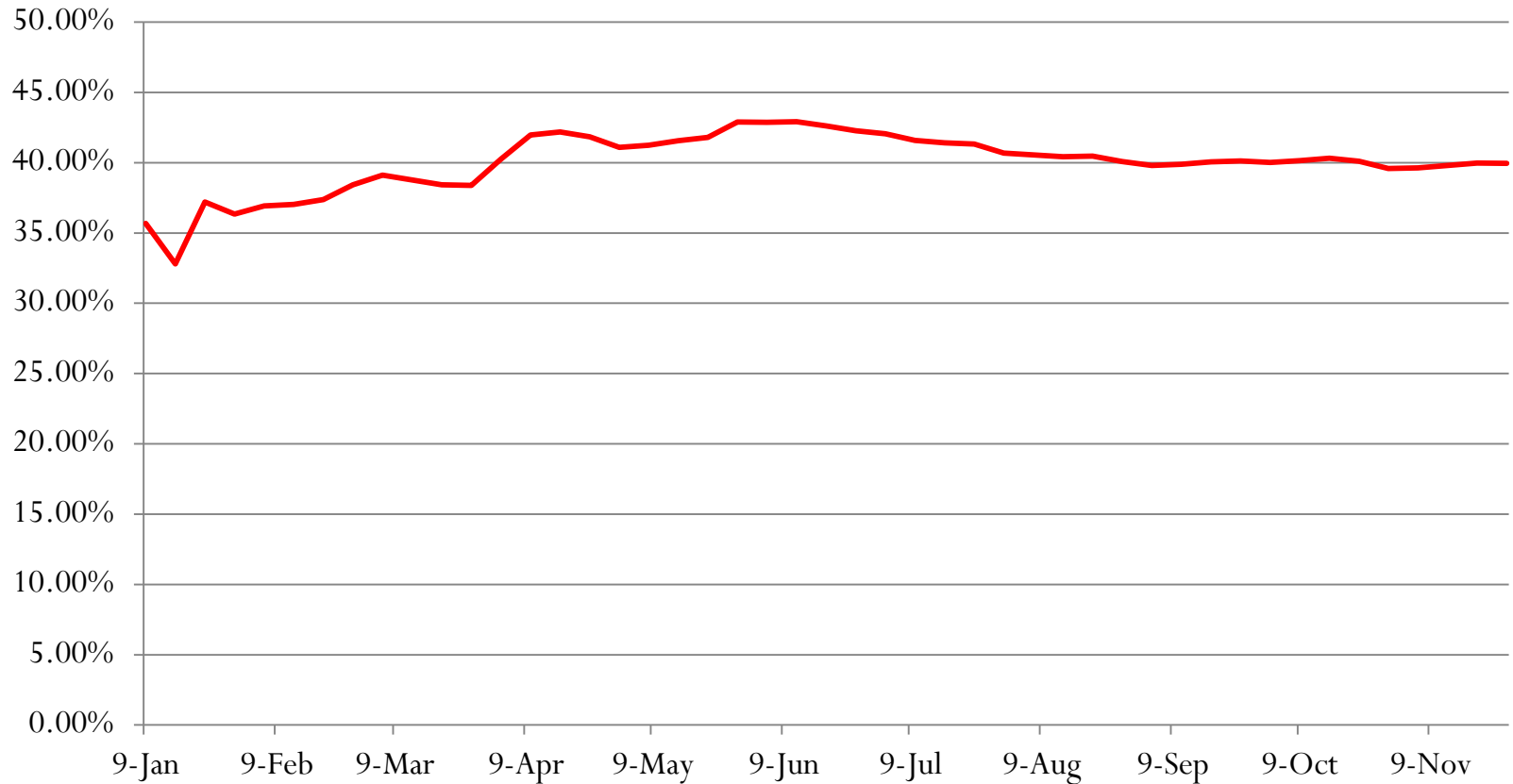

GL1 Exam Results Update

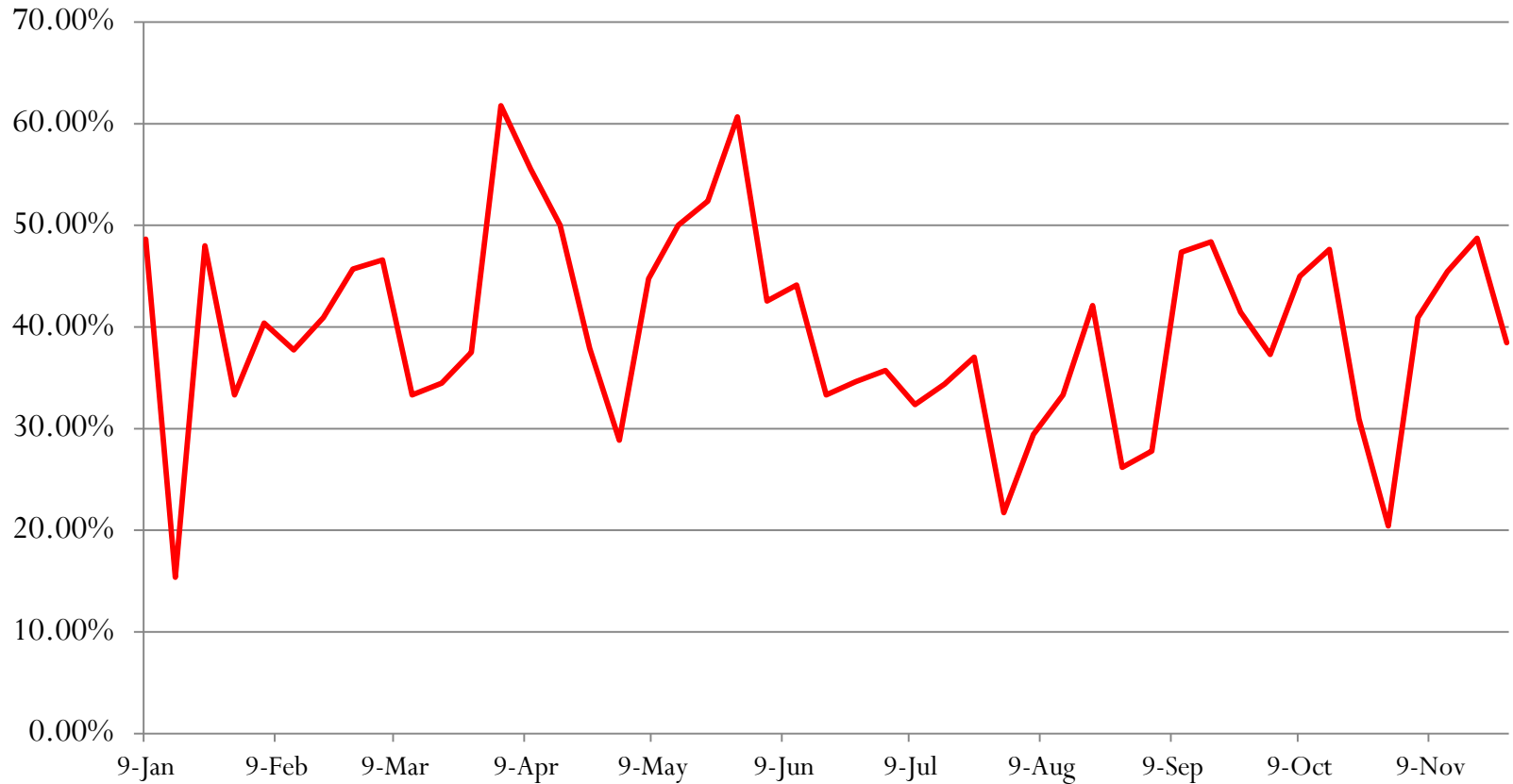
January 2015– Present Cumulative





GL1 Exam Results Update

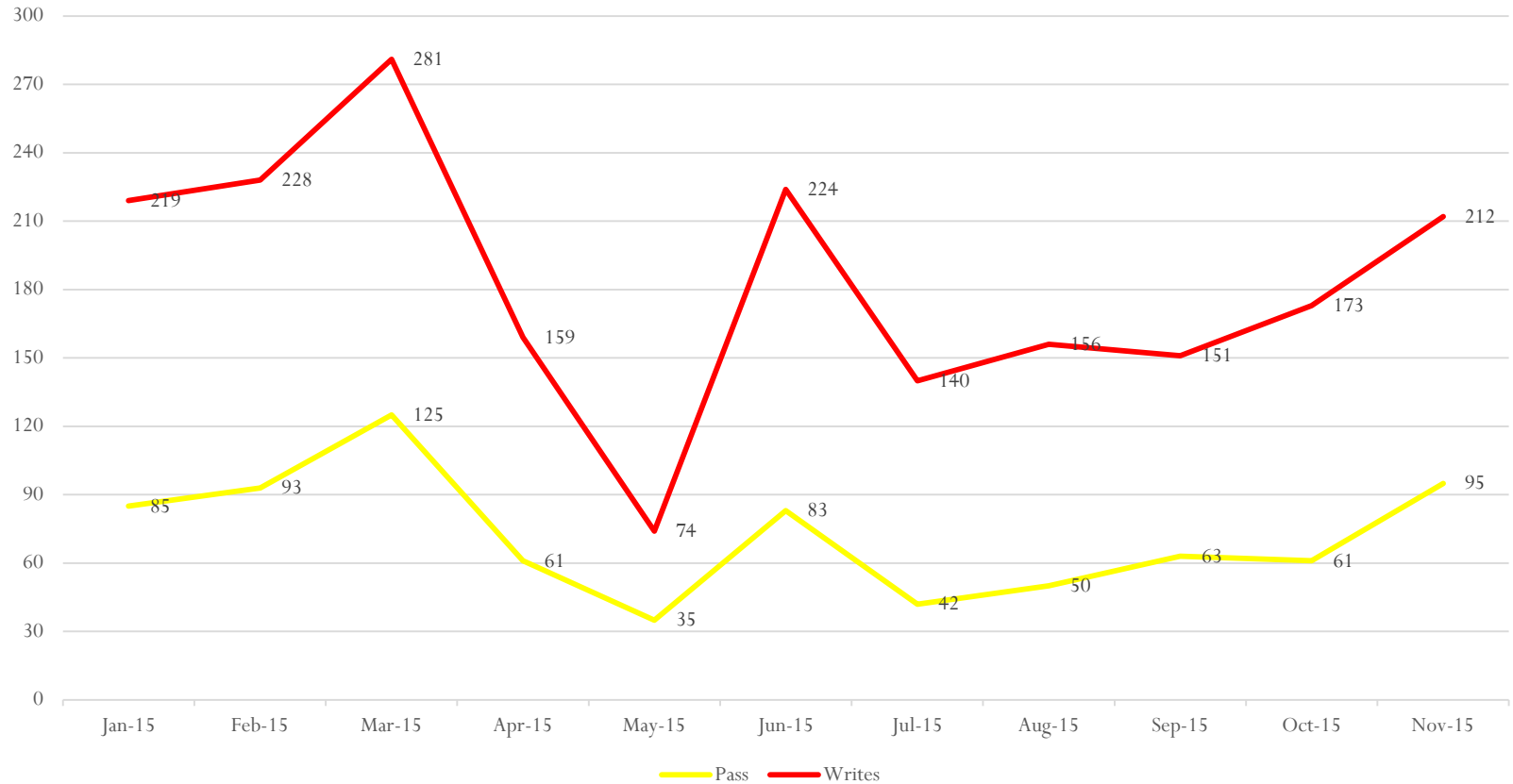
January 2015 – Present Weekly
